Appendix to the Brandwacht aan Rivier Estate Rules

At the Annual General Meeting held by Zoom conference on 20 August 2020 the following Amending/supplementing to the Estate Rules was proposed and approved by members.

"No loud noise, including amongst others loud music, singing and screaming, should take place in the estate on weeknights (Monday to Thursday) by later than 21h00, Friday and Saturday by later than 23h00 and Sunday by later than 21h00.

In the case of members making noise after these times, the rules will be enforced by Security/the Estate manager.

Penalties to be issued to members upon infringement of this rule:

First offence: a warning

Second offence: penalty equal to a quarter of a monthly levy

Third offence penalty equal to a monthly levy

The Trustee Committee is hereby authorised to amend and/or supplement the Estate Rules to reflect and give effect to the aforementioned decision in their discretion."
